

## SHARED RESPONSIBILITY AGREEMENT BETWEEN ORGANIZERS AND PARTICIPANTS QUEEN TROPHY ADVENTOURING

The *Queen Trophy Adventouring* is a national itinerant motorcycle touring event that invites participants to explore some of the most captivating areas of Central Italy. This Agreement of Shared Responsibility defines the mutual commitments between Organizers and Participants, with the aim of ensuring a safe, enjoyable, and memorable experience.

Participation in the event implies full and automatic acceptance of the terms of this Agreement.

### Organizers' Responsibilities

#### A. Route Safety

- **Planning & Verification:** The itinerary includes paved secondary roads, forgotten paths, and sections with natural surfaces, which have been checked multiple times to ensure their feasibility under the safest possible conditions.
- **Alternative route around unpaved sections:** Alternative routes will be available for the more demanding sections, allowing participants to select the path that best matches their skills and experience.

#### B. Technical and Medical Support

- **Ongoing Support:** A qualified medical team and a mechanical support team will be present along the route to provide timely assistance.
- **Emergency Response Vehicles:** Rapid-response support vehicles will be on hand to assist in the event of accidents or mechanical issues.

#### C. Logistics and Services

- **Baggage Transport:** A dedicated service ensures participants can travel light and focus entirely on driving.
- **Refreshment Stations:** Refreshment stations will be available along the route, offering food, water, and opportunities to take a break.

#### D. Info & Communication

- **Constant Updates:** Organizers will provide timely updates on the itinerary, weather, and other key information to ensure participants' safety and comfort.
- **Ways to Stay Connected:** An official channel will be available to provide support and answer any questions.

#### E. Environmental Responsibility

- **Minimized Environmental Impact:** The event is designed to reduce its environmental footprint while fostering respect for nature and local communities.

### Participants' Responsibilities

#### G. Ensuring Your Safety

- **Ensure Your Motorcycle is Road-Legal:** It is mandatory to arrive with a vehicle compliant with traffic regulations and in perfect mechanical condition.
- **Safety Gear:** Wearing a helmet and certified riding gear—including jacket, pants, gloves, boots, and body armor—is mandatory.

- **Following the Rules:** Participants must follow all guidance from organizers and local authorities.

#### **H. Responsible Riding**

- **Cautious riding:** Maintain a respectful and responsible attitude towards other road users and fellow riders.
- **Sobriety:** Participation under the influence of alcohol or drugs is prohibited.
- **Non-competitive event:** The *Queen Trophy Adventouring* is a touring event, not a race. Dangerous behavior, excessive speed, or reckless overtaking will result in immediate disqualification from the event.

#### **I. Respect for the Environment**

- **Waste:** Littering is prohibited. Please use only the designated collection points along the route.
- **Flora & Fauna:** Avoid any behavior that could harm the ecosystems along the route.

#### **J. Compliance with Event Rules**

- **Respect the route:** Follow the official route and attend all mandatory briefing meetings.
- **Collaboration:** Cooperate with the staff to ensure order, safety, and the smooth running of the event.

#### **K. Insurance and Documents**

- **Mandatory documents:** Hold valid motorcycle liability insurance and a driving license that is valid and appropriate for the country where the event takes place.
- **Disclaimer:** The organizers are not responsible for accidents or damages resulting from reckless riding or failure to comply with the rules.

#### **L. Agreement Acceptance**

By participating in the *Queen Trophy Adventouring*, you automatically and fully accept this Agreement. Please read it carefully before completing your registration.

#### **M. Amendments to the Agreement**

The organizers reserve the right to amend this document, promptly informing participants through the official channels.

#### **N. Applicable Law**

This Agreement is governed by Italian law. In the event of any disputes, the competent court shall be that of Perugia.
